Official Answer. Methadone is not usually tested for on a standard 5- or 7-panel drug test unless it has been specifically requested. Specific methadone tests are expensive, and not usually requested by employers. Extended drug panels, such as 10- or 12-panel tests do normally test for methadone. If you are legitimately taking methadone as part of an addiction recovery program, you cannot legally be terminated from employment if methadone does show up in your test results.
